## Continuing Education Information:



The GSHA 2024 Convention will offer UP TO **20.0 hours of continuing education (2.0 CEUs)**. Partial credit is available for the convention if you are unable to attend every session. Participants are required to [report their attendance](#), list 3 learning outcomes and share their ASHA number at the end of convention in order to earn ASHA continuing education credit.

If you do not want your information reported to ASHA for CEUs, we can offer certificates as long as you [complete the submission form](#) to request in a timely manner.

- This form must be completed by **SATURDAY MARCH 9, 2024. LATE SUBMISSIONS WILL NOT BE ACCEPTED.**
- Our Continuing Education Administrator will verify your attendance, convert the contact hours to ASHA CEUs, and send you a certificate of attendance via email. Please keep the program and a copy of this completed form for your records (e.g., verification for Georgia State Licensure).
- We appreciate your patience with the CE reporting process! ASHA approved CE providers have up to 45 days to submit your participation to the CE Registry. It may take up to another 15 days for your ASHA CE Transcript to reflect this conference.
